Under federal law, race discrimination in education is prohibited by Title VI of the Civil Rights Act of 1964. Title VI protects people from discrimination based on race, color or national origin in programs or activities that receive federal financial assistance. Title VI states that:

Race Discrimination in Education - FindLaw The prohibition of education for African Americans had deep roots in American history. According to the 1847 Virginia Criminal Code: “Any white person who shall assemble with slaves, [or] free negroes . . . for the purpose of instructing them to read or write, . . . shall be punished by confinement in the jail . . . and by fine . . .”
