A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business. These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

Sample Corporate Resolution for Signing Authority ...

An LLC member resolution is the written record of a member vote authorizing a specific business action. Formal resolutions aren't necessary for small, everyday decisions. However, they're useful for granting authority to members to transact significant business actions, such as taking out a loan on behalf of the LLC.

Because LLCs have no physical form, they must act through their authorized representatives, their members (owners) and managers, for all purposes. This holds true for signing documents. By default, all members have authority to act on behalf of the LLC.

An LLC is a hybrid business entity that enjoys the operational flexibility of a partnership, but unlike a corporation, doesn't have to follow a particular procedure by law to pass a resolution. An LLC is governed by the consent of its owners.
