Corporate Resolution to Open Bank Account is a special resolution passed in a valid corporate meeting for the purpose of authorizing the company to open a bank account as agreed by the members of the meeting.

A corporate resolution for a bank account is a statement listing the names of officers authorized to do business on the corporation's behalf. Corporations need bank accounts to create a separate holding place for money associated with their business, and banks must know who represents the corporation as they do business together.

A board resolution (bank employees will often call it "BR") is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a

bank account in addition to other documents.

A common example of a corporate resolution is one that notifies a bank that a specific executive in the business has the authority to access corporate funds, sign checks, and acquire loans on behalf of the corporation. 1 Corporations are separate entities from their owners and they have separate liability from these owners.

What to Include in a Corporate Resolution

A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business. These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

Sample Corporate Resolution for Signing Authority ...

RESOLVED: That the Company execute and deliver to said bank a duly signed original of the completed banking resolution as is hereto attached, and the authority to transact business, including but not limited to the maintenance of savings, checking and other accounts as well as borrowing by the Company, shall be contained in said resolution with the named officers therein authorized to so act on behalf of the Company as specified hereto.

CORPORATE RESOLUTION OF

A banking resolution is the simplest way for a company to authorize opening a bank account. This document is required to properly record company decisions and to prove to financial institutions that the person applying for an account is authorized to act on behalf of the company.
