Corporate Signature Resolution

A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business. These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

Sample Corporate Resolution for Signing Authority ...

After the Corporate Resolution Is Signed . The corporation's secretary has the role of filing all corporate resolutions in the corporate records book. These resolutions don't need to be submitted to any governmental agency, but they must be available if the corporation is audited by the IRS or other agency, or by the business department in the state where the corporation is located.

What to Include in a Corporate Resolution

Each authorized individual's Social Security number, date of birth, citizenship, mailing address, income sources, and associations. The corporate resolution must include the signature of the corporate officer and the corporate
