Type "Dear Sir or Madam" followed by a colon. If the school is small, you can call and request the name of the person who handles the appeals and address it to him. Larger schools typically have several people who handle appeals, so you may have to use the general salutation. Begin the letter by stating that you are appealing your academic expulsion.
