Format of Board Resolution for Authorisation to Sign Agreement

A certified corporate resolution is a resolution made at a directors' or shareholders' meeting that has been approved by the secretary and president

of the corporation. This type of resolution is useful if a bank or other external organization ever requires verification to permit specific actions or powers, such as the authority to sign documents on behalf of the corporation.
