Possible Punishments for Federal Racketeering (RICO) Racketeering / Illegally Conducting an Enterprise. In 1987, the United States Sentencing Commission presented its Sentencing Guidelines. One of the goals of the Sentencing Commission was to bring about tougher sentencing for “White Collar crimes”. Even the most minor White Collar felonies would draw incarceration under the guidelines.

Minimum Sentence for Racketeering (RICO)

The racketeering conspiracy count carries with it a maximum 20-year sentence but the sentencing guidelines call for a sentence in the range of 33-41 months, based on her lack of a criminal record and taking responsibility for her wrongdoing.

When sentencing an offender for an offence committed before 6 April 2010, the courts must have regard to any relevant sentencing guidelines. Sentencing guidelines are available for most of the significant offences sentenced in the magistrates’ court and for a wide range of offences in the Crown Court. There is also guidance on general sentencing issues and principles. These guidelines are not specific to individual offences.

About guidelines - Sentencing
