Regarding the third option, the NCUA

amended the Supervisory Committee Guide in 1999 to detail the minimum scope and procedures for engaging Start Printed Page 53304 outside, compensated professionals in the audit process and to clearly distinguish a Supervisory Committee Guide audit from a financial statement audit. The Supervisory Committee Guide is not included in the NCUA's regulations and instead is available on the agency's website.

Research and ensure responses to member complaints In smaller non-complex credit unions, the Supervisory

Committee functions help to compensate for limited internal controls. It is not the responsibility of the Committee to make operating decisions.

Supervisory Committee Duties and Responsibilities

Supervisory committees should meet at least quarterly (and more frequently where practical) to review the credit union's financial position with management. If there is an internal auditor, or if reports are completed by outside firms, the committee should also meet with the internal auditor to review reports.

Supervisory Committee Roles and Responsibilities

Gather Supervisory Committee. Gather's Supervisory Committee consists of five volunteers who are responsible for the safety and soundness of our credit union. They are independent from the Board of Directors and Management and are tasked with ensuring member interests are protected. The Committee oversees the Internal Audit department and engages an external accounting firm to conduct an annual opinion audit of Gather's financial statements.

One such option is to conduct an audit per the Supervisory Committee Guide, which is published by the NCUA. The Board is proposing to replace this option with the option to conduct the audit so as to meet certain minimum requirements, which would be incorporated into a proposed new Appendix A to Part 715.

on a proposal outlining and confirming the agencies' use of supervisory guidance for regulated institutions. The proposal would codify the statement, as amended, that was issued in September 2018 by the agencies that clarified the differences between regulations and guidance.

The Supervisory Committee is responsible for ensuring that the Credit Union's Board of Directors and management establish practices and procedures to properly safeguard members' assets. In addition, the Committee is

responsible for the annual financial statement audit from a licensed, independent auditor. In accordance with the Federal Credit Union Act, the Supervisory Committee is comprised of volunteer members and functions completely independently of Credit Union management.

The NCUA recently adopted new regulations related to the audit requirements for supervisory committees. This session will review these new
