Boundary disputes can be uncomfortable and the quicker you can move to resolve them, the better. In England and Wales, there is usually no record kept on the precise boundaries between properties. There is also usually no registered record of who owns, and is responsible for, hedges, trees, walls, fences or driveways between properties.

A boundary dispute is a dispute between the owners or occupiers of neighbouring properties. This may take many forms but usually causes parties to question a boundary line or the construction of a new boundary between properties.
