Genetic Discrimination And Genetic Privacy

Although GINA is best known for its provisions prohibiting discrimination based on genetic information, it also contains provisions related to privacy. Section 202 (b) of GINA prohibits employers from requesting, requiring, or purchasing genetic information with respect to an employee (including an applicant) or a family member of the employee.

The Genetic Information and Nondiscrimination Act of 2008 (GINA) protects the genetic privacy of the public, including research participants. The passage of GINA makes it illegal for health insurers or employers from requesting or requiring genetic information of an individual or of family members (and further prohibits the discriminatory use of such information).

Although the law protects against discrimination on the basis of genetic information, this protection does not extend to "manifested conditions". The genetic information is protected under the law, even if symptoms begin, but the symptoms themselves are not protected.

In 1995, EEOC issued an interpretation that discrimination based on genetic information relating to illness, disease, or other disorders is prohibited by the ADA. In a subsequent Senate hearing in 2000, EEOC Commissioner Paul Miller further affirmed that the ADA "can be interpreted to prohibit employment discrimination based on genetic information."

The idea of genetic discrimination has been combated since the 1947 Nuremberg Code that was created shortly after WWII, during which thousands of racialized victims died in tests conducted in Germany. Title II of the Genetic Information Nondiscrimination Act of 2008 (GINA), which prohibits genetic information discrimination in employment, took effect on November 21, 2009. Under Title II of GINA, it is illegal to discriminate against employees or applicants because of genetic information.
