Notwithstanding the absence of binding competition rules within the WTO, competition concerns have long been a staple question within the international trading system. The draft of the 1948 Havana Charter, which was designed to create the International Trade Organization (ITO), addressed the possibility that international cartels and restrictive business practices would frustrate market access.

The WTO is the forum where 164 member nations negotiate global trade rules, primarily through

multi-year rounds of multilateral negotiations such as the current Doha Round, and settle disputes over tariff and non-tariff trade barriers.

A striking similarity exists between the objectives of the WTO and those of competition policy. The key concepts common to both are, inter alia, promotion of an open market, provision of fair and equal business opportunities to every participant in the market, transparency and fairness in the regulatory process, the promotion of efficiency, and the maximization of consumer welfare.

The default position in WTO rules is that subsidies are generally allowed, while EU rules consider subsidies to be generally illegal. WTO rules apply to goods, but EU rules include services too. EU rules are applied prospectively (i.e. legality must be proved before awarding any support), while WTO rules are only reactive, and are only triggered if a member country lodges a complaint.

The WTO establishes that “All import restrictions are illegal unless proven scientifically” (Lawrence & Weber, 2014) and provides settlement of any complaints or disputes by its Dispute Settlement Body (DSB) which provides binding rulings towards the dispute. This provides a process and venue for trade justice and fairness settlements.

Supporters of a competition law agreement in the WTO emphasise the success the WTO has had in other fields of law, like the continuous reductions of governmental trade barriers, the extensive possibilities for negotiation even in other fields of the WTO forum and effective structures of the WTO, especially the Dispute Settlement Body (DSB).

I believe therefore that WTO dispute settlement should not be considered as a stumbling block for a decision to launch negotiations on a multilateral framework of competition rules. While a number of difficult issues will need to be resolved, the WTO could certainly employ its traditional pragmatism to find solutions which are well adapted to the specificities of competition law and policy.
