The Missouri lemon law is a measure designed to protect buyers of new cars in the event their vehicles experience significant defects. The lemon law helps to enforce the manufacturer's warranty on the vehicle so that the manufacturer either repairs the car, or offers the customer a replacement vehicle or a refund.

The Missouri New Vehicles Warranty Law, commonly called the "Missouri Lemon Law," protects buyers of new vehicles by enforcing

the manufacturer's express warranty. The Missouri Lemon Law does not apply to used cars. All new vehicles sold or leased with warranty provisions are covered under the lemon law, except for commercial and off-road vehicles, mopeds, motorcycles and the non-chassis portion of recreational vehicles.

Missouri Lemon Law

The Missouri Lemon Law covers you when your car's use, value, and/or safety are substantially impaired (negatively impacted) by its defects. This makes sense because like most people, you bought a new car with a new car price so you would have peace of mind and wouldn't have to deal with used car problems.

A "lemon" is a new car with recurring problems that the dealership is unable to fix within a certain period of time (usually one year in Missouri). Lemon laws, therefore, are intended to protect consumers from being stuck with a new vehicle that is inoperable or seriously problematic. These laws don't protect buyers of used cars, although some states (not included Missouri) have similar but less-robust protections for used car purchases as well. Missouri Lemon Laws at a Glance

Missouri Lemon Laws - FindLaw

Missouri's lemon law protects owners of new motor vehicles. To

receive benefits under Missouri's lemon law, you must provide the manufacturer and the dealer with notice of the vehicle's problem within one year of the purchase date. The manufacturer or dealer can perform the repairs outside of the first year.

Missouri Lemon Law is that in order to meet its requirements the problems with your vehicle must take place very early on – during the term of the express warranties or during a period of one year following the date of the new motor vehicle's original delivery to the consumer, whichever comes first.

While the lemon laws from state to state may differ, at the very least the federal Magnuson-Moss Warranty Act, also known as the federal Lemon Law, will provide protection to the purchasers of used cars so long as the vehicle was sold with some type of warranty

or service contract, i.e., was not sold as-is. The federal Lemon Law, which Congress enacted in 1975, requires that car dealers or car manufacturers comply with the terms of any warranties or service contracts that accompany the used car.

FAQs About Missouri Lemon Law

If your vehicle has been out of commission for more than 30 business days, the car may be a lemon. The Missouri lemon law only applies to new vehicles within the first 18 months from purchase or lease-purchase vehicles that are still under the original manufacturer's warranty.
