Company resolution - Ordinary and special resolution

At a company's general meeting, which shareholders attend to discuss matters relating to the company, any decisions made by the members are ratified by means of a company resolution. The requirements for this are set out in the Companies Act and the articles of association and any resolutions made must adhere to these requirements.

What is a Company Resolution?

The company in turn should give members the notice of that resolution at least seven days before the holding of the meeting. Such resolution may be ordinary or special resolution. Following are some of the resolutions requiring special notice: (1) Resolution to remove a director. (2) Resolution to fill up a casual vacancy of the director.

Types of resolution in company law When the board or the members of a company take a legally binding decision, this is known as a 'resolution'. A resolution is passed if it achieves the requisite number of votes, and if taken at an annual meeting is binding on the company provided that:
