States With Specific Autism Mandates - ASHA

How Laws Mandate Coverage. Many states in the United States require health insurance companies to cover costs associated with autism treatment, and this coverage might last for a lifetime. As of June 2017, the District of Columbia and 46 states mandated that insurance companies cover autism treatment through laws that have been passed.

How Much ABA Therapy Costs (State by State)

The Tennessee Department of Commerce and Insurance now requires all individual, small and large group insurance plans issued in the state to cover treatment for autism that is "medically necessary and appropriate and is not experimental," including applied behavior analysis, or ABA, at the same level as any other medical condition.

Autism Insurance Coverage Now Required In All 50 States

... In the past 10 years, Autism Speaks and other advocates have worked hard, and as a result, 46 states have now passed Autism Mandate Laws. Each state has slight variances, but for the most part, these mandates guarantee insurance coverage for ABA therapy for families who have a fully insured, private insurance

policy.

The green states require coverage for ABA. However, some states limit this coverage with age, dollar or hour caps resulting in disparities in coverage between states. Some state autism insurance laws exempt or “carve out” one or more plan types from coverage requirements. For example, some state legislatures did not include SEHB plans in laws to require coverage for autism treatments, citing a fiscal impact. However, the policy will never include ABA coverage because of the state mandate. It is critical to always call on benefits in case the policy is a self-funded plan. Medicaid, CHP+, and State Employees: Coverage of ABA on these policies varies in each state. Some states have ABA included and others do not.

Out of the 33 states that specify a maximum coverage amount, Wisconsin, Arkansas, South Carolina, and Kentucky are the only states with a maximum yearly coverage amount up to \$50,000, which covers the average cost of ABA Therapy for one year. Nevada has the highest maximum coverage amount at \$75,000 per year.

The Most Supportive States for Raising a Child With Autism ...

Several states enacted legislation in 2015 addressing mandated autism coverage including: Colorado, Georgia, Kansas, Missouri, South Dakota, Virginia and Washington. Mandated coverage may be limited to specific age groups, number of annual visits or by an annual spending cap.

Autism and Insurance Coverage | State Laws

Specific Insurance Mandate. The state of Texas has a specific autism mandate. The mandate requires a health benefit plan to

provide coverage to an enrollee who is diagnosed with autism spectrum disorder from the date of diagnosis until the enrollee completes nine years of age. If an enrollee who is being treated for autism spectrum disorder becomes 10 years of age or older and continues to need treatment, this does not preclude coverage of treatment and services.

Texas Insurance Requirements for Autism Spectrum Disorder

By 2015, a total of 41 states and the District of Columbia had enacted some level of autism coverage insurance mandates, and 29 states have enacted regulations that require autism coverage to be included on all plans sold through the exchange. But the specifics in the mandates vary significantly from one state to another.

How is autism covered under the Affordable Care Act ...

Due to unwavering advocacy in Tennessee and the fact that 46 other states have mandated coverage for ABA for autism, as of January 1, 2018 Blue Cross and Blue Shield of Tennessee (BCBS-T), UnitedHealthcare (UHC) and Cigna have voluntarily added coverage for ABA in many of their fully insured plans.
