Covered California listed the single adult Medi-Cal annual income level, 138% of FPL, at \$17,237 and for a two-adult household at \$23,226. The DHCS 2020 FPL income chart lists a higher amount of \$17,609 for a single adult and \$23,792 for two adults.

If an adult is under 138 percent, based on their monthly income, they are determined eligible for Medi-Cal and ineligible for the Covered California subsidy. The threshold for Medi-Cal, 138% FPL, jumped from \$17,237 on the September chart up to \$17,609 on the new revised income table.

Revised 2020 Covered California Income Eligibility Chart

Simply put, if a non-applicant spouse has income under \$3,216 / month, the applicant spouse can transfer his / her income to the non-applicant spouse to bring his / her monthly income to this level. This spousal allowance rule allows the Medicaid applicant to transfer income to the non-applicant spouse to ensure he or she has sufficient funds with which to live.

In 2019 it was raised to \$68,495. If the family income at renewal time was \$66,800, all members of the 4-person household were Covered California eligible. In 2019, if the same family raises the income to \$68,000, that is under the 2019 266% of the FPL and MAY automatically make the children Medi-Cal eligible.

Covered California Eligibility. For a single adult applying through Covered California, the monthly income must be greater than 138% of the Federal Poverty Level (\$1,397 monthly, \$16,754 annually) in order to qualify for private health insurance with the premium tax credit subsidy. If the individual or household is below 138% of the FPL, they will be deemed eligible for Medi-Cal.
