Remedial Constructive Trust For Breach of Fiduciary Duty. A breach of fiduciary duty may traditionally give rise to a remedial constructive trust that is imposed upon the asset(s). A constructive trust is an aspect of the creative jurisdiction of equity. It is an implied trust created by the courts when it is unconscionable for a defendant with the legal title to property to claim that property (or some part) beneficially to the prejudice of the claimant. The trust is created independently of the intentions of the parties.

Constructive Trusts I

The property is held in "constructive trust" for the harmed party, obliging the defendant to look after it. The main factors that lead to a constructive trust are unconscionable dealings with property, profits from unlawful acts, and unauthorised profits by a fiduciary. Where the owner of a property deals with it in a way that denies or impedes the rights of some other person over that property, the courts may order that

owner to hold it in constructive trust.

In addition to damages, courts may order a constructive trust to control funds, proceeds, and property obtained as a result of a breach of duty, a forfeiture of fees (common in professional fiduciary / client relationships), and profit disgorgement to return any profits obtained from the breach of duty.
