The North Carolina income tax withholding requirement applies when the payee is expected to be paid more than \$1,500 during the calendar year. Tax is not required to be withheld from a payment of compensation to a payee if the payment is \$1,500 or less and, at the time the payment is made, the payer does not believe that the total compensation to be paid to the payee during the year will exceed \$1,500.

Employer Tax Credit Under North Carolina's COVID-19 Recovery Act (S.L. 2020-3), employers will receive a tax credit towards their contribution to the state's Unemployment Insurance Fund. The credit is equal to the amount of the employer's contribution due to the fund for the first quarter of 2020.

NCDOR: Documents

You are required to pay taxes if you are:

A general business employer with gross payroll of at least \$1,500 in any calendar quarter or with at least one worker in 20 different weeks during a calendar year.

An employer who acquires all or any portion of a liable business in North Carolina. An employer who voluntarily elects to become liable regardless of not meeting the required criteria.

State Unemployment Tax & Rate. In North Carolina, the new employer SUI (state unemployment insurance) rate is 1.0 percent on the first \$25,200 of wages for each employee. Employers with previous employees may be subject to a different rate. This an employer-only tax. Workers' Compensation Insurance

Household Employment in North Carolina

Employers are required to file the Quarterly Tax and Wage Report (Form NCUI 101) for each quarter, beginning with the quarter in which employment begins. Tax must be paid on each employee's wages up to the taxable wage base for each calendar year. Quarterly wages must be reported for each employee by name and Social Security number.
