The relating provisions are as below: (1) No resolution shall be deemed to have been duly passed by the Board or by a committee thereof by circulation, unless the resolution has been circulated in draft, together with the necessary papers, if any, to all ...

Resolution by circulation under Companies Act 2013 read ...

an ordinary resolution, which is a resolution that is supported by more than 50% of the directors. However, section 248A of the Act clarifies that for a resolution to be passed without a meeting, all of the directors entitled to vote on the resolution must sign the document.
