Montana Quit Claim Deed

The Montana quit claim deed is a legal form that allows the conveyance or transfer of real property (land and buildings) from one person, usually called the grantor, to another, usually called the grantee. A quit claim deed is different from a warranty deed because it does not come with a guarantee from the grantor as to the title.
