The doctrine of legitimate expectation was first developed in English law as a ground of judicial review in administrative law to protect a procedural or substantive interest when a public authority rescinds from a representation made to a person. It is based on the principles of natural justice and fairness, and seeks to prevent authorities from abusing power.

The doctrine of legitimate expectation has two aspects: procedural as well as substantive. In *Schmidt*, Lord Denning introduced procedural legitimate expectation particularly with reference to the application of principles of natural justice to administrative action and it is now well established in India. Principles of natural justice will apply to administrative actions when there has been a promise or a long standing practice for following the same.
