The exclusive right-to-sell listing agreement is a contract from a seller of real estate that gives a real estate agent the sole rights to procure the sale. The agreement outlines the real estate agent’s compensation, which is usually based on a percentage (%) of the sales price at closing, along with other terms and conditions.

Exclusive Right to Sell v. Exclusive Agency Listing Agreement

In an exclusive right-to-sell agreement, the seller will be responsible for paying the realtor fees even if they find the buyer completely on their own. With an exclusive agency listing, the seller will only pay fees in the event the realtor finds the final buyer.

Difference Between Exclusive Right to Sell & Exclusive Agency

The Exclusive Right-to-Sell agreement means that it doesn't matter who found the buyer for the real state; even if it was another agent, or if the seller managed to find a buyer for the property themselves, the broker must still be paid. Even if, for example, a friend or family member of the seller decides to buy the property — or the seller mentioned on social media that the house was for sale — the agent must be paid, even if they had nothing to do with the ultimate buyer of the property.

EXCLUSIVE RIGHT TO SELL BROKERAGE AGREEMENT

In an exclusive right to sell agreement, if your real estate agent goes on vacation and you find a buyer on your own, the real estate agent still gets their commission even if you did all the work yourself in their absence. If you want to be hands-off in the sale of your house, this type of agreement might work fine.
