The rules governing partnership taxation, for purposes of the U.S. Federal income tax, are codified according to Subchapter K of Chapter 1 of the U.S. Internal Revenue Code. Partnerships are "flow-through" entities. Flow-through taxation means that the entity does not pay taxes on its income. Instead, the owners of the entity pay tax on their "distributive share" of the entity's taxable income, even if no funds are distributed by the partnership to the owners. Federal tax law permits the owners

If the IP invests in marketable securities and meets the definition of an investment partnership under Regs. Sec. 1.704-3(e)(3)(iii)(B)(2) (90% of its assets must be actively traded property), then partnership income or loss is permitted to be

This means that the individual partners are subject to tax on their share of the profits realised in the partnership. The partnership itself does not pay income or capital gains tax. However, it must still prepare and submit a tax return which details the taxable profits of the partnership and how those profits are split between the partners.

For all types of partnership, the general rule is that tax is not payable by the partnership itself but by each partner. Each partner's share of the partnership income is added to his or her other taxable income. The partner pays tax on the total of his or her earnings, including their share of the partnership profits.
