Abstract. Welsh v. United States (1970) presented the Supreme Court with the problem of whether conscientious objector status had to be extended to a person who rejected participation in war as a matter of conscience, but who was an avowed atheist. When it ruled in Welsh's favor, the Court offered the fullest answer it has yet given to a central constitutional problem: the definition of the "religion" which is protected by the First Amendment.
