The capital introduction might be in cash form or non cash form such as equipment, machinery, buildings, or accounts receivable. If the capital is introduced in non cash form, it is always brought into the partnership at fair value.

Step 1 - Calculate goodwill. The total book value of the partnership is equal to the combined value of the partners' capital and current accounts, or

\$122,300 (\$60,000 + \$12,800 + \$40,000 + \$9,500) The partnership is valued at \$164,300. Therefore, the goodwill is valued at \$42,000 (\$164,300 - \$122,300).
