At the end of the Form E each party

must sign a 'statement of truth' which confirms that the information they have given is a full, frank, clear and accurate disclosure of his or her financial and other relevant circumstances. It includes a warning that anyone making false statement on the Form E may face Contempt of Court charges.

If you are taking part in a financial application in a court setting, you will need to complete a Form E as part of that process. This is a lengthy form, requiring detailed information about your financial situation, and asking you to attach significant amounts of documentation in support of your answers.

You have to fill in a financial statement (Form E) if you are going to court in England or Wales to get a financial order after you've split up with your ex-husband, wife or civil partner. Form E1 – this is the document that

should be used for any other financial remedy in the County Court (in other words, do not use this form if you are divorcing your spouse or civil partner). Form E1 is suitable for claims made on behalf of children under Schedule 1 Children Act 1989 (for instance, if the children's parents are not married or in a civil partnership).

How to apply for a financial order without the help of a ...

If you (or your spouse or civil partner) apply to the court for a financial order or financial relief, both you and the other person must fill in a separate Form E. You must send your filled-in Form E to the court and a copy to the other person, no later than 35 days before the date of the

first appointment.

Notes for guidance - Berwins Solicitors

An Electronic Filing Agent (EFA) cannot certify the financial statements of a company: An EFA can sign a B1 (annual return) form on behalf of a company once s/he has been authorised by the company to do so on a B77 form. However, the 2014 Companies Act requires that the financial statements must be certified by a Director and Secretary of the company (original signatures).
