Trial by jury enables the case against a defendant to be determined by his peers, who are free to apply their view of justice rather than adhere strictly to the rules of law. In R v Ponting a civil servant was charged with breaching the Official Secrets Act for releasing privileged information about the sinking of the General Belgrano. The judge

told the jury that public interest in the information did not provide a defence.
