It is a claim made by the respondent or defendant that the other party is misusing or perverting regularly issued court process (civil or criminal) not justified by the underlying legal action.

On the contrary, the power to rule a proceeding as an abuse of process exists 'precisely to prevent the court's processes being abused through the lawful and literal application of the rules'.

An abuse of process is the commencement of legal proceedings, either criminal or civil, against another person maliciously and without proper cause.

Where the conduct of the first action has been found to have been an abuse of process or otherwise inexcusable, then the second action will be struck out as an abuse of process, save in “very unusual circumstances”. (Other terminology might equally be used to indicate this strict approach).

The tort of beginning or otherwise using the judicial civil or criminal process for an improper purpose. There may be a legitimate basis for instituting or using the judicial process, but the actual intent behind the action is improper. See also malicious prosecution.
