Public policy exception is a rule of exception to the employment-at-will rule. Under this exception, an employer can not fire or discharge an employee if it would violate the doctrine of public policy of a state or a state statute or federal statute. An employer cannot react against an employee for performing an action in accordance with public policy.

The Application of the Public Policy Exception in Various ...

Indeed, in most, the public policy violation must reach a certain threshold to warrant refusing enforcement, such as “blatant”, “flagrant” or “intolerable”. The exception can legitimately apply, for instance, to awards concerning contracts that would be illegal under national laws (such as those concerning crime).

The easiest category to accept as a “public policy” exception to employment-at-will involves employer demands that employees violate the law. A principle that no person or government official can legally perform an act that tends to injure the public. Public policy manifests the common sense and common conscience of the citizens as a whole that extends throughout the state and is applied to matters of public health, safety, and welfare.

Public Policy legal definition of Public Policy

One is in the context of a domestic arbitration- under Section 34 where an

arbitration award can be set aside if it contravenes the public policy. The other is in the context of a foreign arbitration- under Section 48 where the enforcement of a foreign arbitral award can be refused if it is in contravention of the public policy of the state.
