A bail authority can make one of four decisions when deciding whether to grant bail to an accused: Release the accused without bail. Dispense with bail. Release the accused with bail. Refuse bail. These options may be exercised while the case is pending. The bail authority loses its power to make a bail decision after the case ends.
